## **BUDGET CALL CIRCULAR FOR THE PREPARATION AND SUBMISSION OF 2025 BUDGET**

#### 1.0 INTRODUCTION

The 2025 Budget Call Circular sets out the requirements and policy guidelines that all Ministries, Departments, and Agencies (MDAs) will follow in preparing the State 2025 Budget. The 2025 – 2027 Medium Term Expenditure Framework (MTEF) consisting of the Economic and Fiscal Update (EFU), Fiscal Strategy Paper (FSP), and Budget Policy Statement (BPS) among others were developed in accordance with the International Public Financial Management best practices to guide policymakers and implementing MDAs to achieve effective Budget Preparation for the coming year. In development to the above, I am directed to write and inform all MDAs that this has set the stage for the commencement of the Budget Preparation for 2025.

In furtherance to this, MDAs may wish to know that in the course of the preparation and production of the MTEF document, all the main Budget components (Revenue and Expenditure) have been well enunciated and adjusted to fit into the current realities and the Government priorities. The projection has, to a large extent, provided a genuine fiscal outline as highlighted in the State's policy priorities and objectives. Hence, the focus of the year 2025 Budget is to help strengthen this administration's target of achieving sustainable development and growth as well as consolidate the gains already achieved amid scarce resources.

In light of the foregoing, this Budget Call Circular intends to provide instructions and guidelines to all Honourable Commissioners, Permanent Secretaries/Chief Executives, Directors, and other officers saddled with the responsibility of the formulation, preparation, consolidation, and submission of the 2025 Budget Proposals of their respective MDAs. In line with this, all Accounting Officers are to carefully go through the Call Circular, adhere strictly to the instructions as stipulated in its contents, and comply with the instructions and guidelines.

#### 2.0 RESPONSIBILITIES OF MDAs ON THEIR SECTOR STRATEGIES

It is quite understandable that by now MDAs must know that the basis behind their creation and establishment is to translate Government policies and programmes into reality employing using the Budget as an instrument towards achieving it. For the MDAs to realize this, they must focus strictly on their Policies, Programmes, Projects, Objectives, and Activities that clearly distinguish them from their sister MDAs that are, though related in their activities, but differ in their mode of operations.

It is against this backdrop that MDAs are strongly advised to visit their archives, look at the law establishing them, identify their aims and objectives, and identify their strategic programmes and projects in the State Development Plan that will address the current and future needs of the Government and make a financial commitment to them by taking into consideration the Budget Envelop allocated to them.

In a situation where your Budget Envelop cannot accommodate your projects or programmes for the Year 2025 Budget, kindly re-prioritize and select the most critical ones using the concept of opportunity cost. The era of admitting too many unrealistic projects and programmes will not be welcomed.

As MDAs embark on this exercise they should also know that the State's Fiscal Policy is targeted to control and enforce compliance with established spending limits to attain a sound budgeting system, which includes aggregate fiscal discipline, efficiency, and effective spending. In line with this, the overall focus of the fiscal framework is to ensure:

- Only prioritized projects contained in the sectors' MTSS should be captured in the MDA capital budget proposal;
- Budget preparation and submissions for capital projects must include full lifetime capital investment requirements (costs) and also sources of funding (particularly if Aids/Grants and/or Loans are being used to partly or completely fund the project);
- Identify the goals and objectives of the MDA;
- > Identify programmes and projects that are aimed at achieving the goals and objectives of the MDA in relation to government priority;
- Spread the programmes and projects over the period of three years most especially where they cannot be completed within a year;

- All capital budgets should be derived from priority areas of the Government and must be costed (attach Bill of Quantity);
- MDAs must provide a cost-benefit analysis and His Excellency's approval for new capital proposals in their submissions;
- Making sure that all ongoing projects and programmes that have a direct bearing on the lives of the citizens are completed as at when due;
- Capital projects are to be prioritized based on their contributions to the economic and social development of the State in line with the Government development agenda;
- Consideration shall be given to climate change adaptation and mitigation, especially to projects with negative impacts on the climate; and
- > Exploring more sources of funds most especially from the development partners and donor organizations.

#### 3.0 PROPOSED 2025 BUDGET:

#### 3.1 POLICY FOCUS AND PRIORITIES

MDAs need to note that the Nigeria Governor's Forum (NGF) secretariat has improved upon the Budget Preparation Application Template that will be used for the 2025 Budget Preparation. The Application Template covers all the Budget Components as well as the Six (6) Segments of the IPSAS National Charts of Accounts. These Application Templates, though relatively new, is meant to be use by the 36 States of the Federation for the preparation of the 2025 Budget. You may also wish to recall that the present 2024 Approved Budget is on the same Template with modification for the 2025 Budget.

It also important for MDAs to know that the Ministry of Budget, Planning and Multilateral Coordination, has improvise the template to suit the purpose for the preparation of the 2025 Budget by MDAs. This we believe will help to facilitate the preparation of 2025 Budget within the stipulated period. On this note the template are labelled accordingly for guidance and ease of reference.

Meanwhile, in connection with the Consideration for the Annual Budget as highlighted in item **2.0** above, the Priority Areas of the Present Administration as enumerated below should be the driving force for each allocation. Hence, the following are the Priority Areas for consideration:

- a. Education;
- b. Health;
- c. Agriculture;
- d. Youth and Women empowerment, job creation, and community development;
- e. Poverty reduction through the establishment of small-scale industries, mining, tourism, and cooperative societies;
- f. Infrastructure through provision and rehabilitation of roads, including urban and rural roads; and
- g. Water Sanitation and Hygiene.

#### 4.0 REVENUE ESTIMATES

# 4.1 Recurrent Revenues (Statutory Allocation and Internally Generated Revenue - IGR)

The Focus of the 2025 Budget in making life hopeful and meaningful for the people of the State requires huge finances, as such all sources of revenues and other alternatives in funding the Budget should be identified and vigorously explored and generated to meet the demands of the Government.

Concerning this, it is mandatory for all Revenue Generating MDAs to go through **Appendix "A" Template** and provide the following information:

- ✓ Identify relevant Revenue Budget Line Items applicable to them,
- ✓ Identify the related Economic Code for the identified Budget Line Item,
- ✓ Reflect the 2024 Approved Budget (if any),
- ✓ Provide Actual Collections for January June 2024, and
- ✓ Make the corresponding allocation on the Proposed Revenue amount for the year 2025 in the appropriate column.

New revenue items should also be captured below the existing Approved revenue items.

### 4.2 Capital Receipts/Aids and Grants

It is also highly advisable that MDAs enjoying donations and facilities from Donor Agencies or Development Partners in terms of Aids and Grants, Loans, and Other Capital Receipts should use *Appendix "B" Templates* in supplying the following needed data:

- ✓ Reflect the 2024 Approved Budget,
- ✓ Provide details of Actual Receipts from January June 2024,
- ✓ Make realistic projections of what is expected in the year 2025 to the corresponding Budget Line Item.

The above should be done by taking into cognizance of the Budget Line Item Economic Code.

#### 5.0 RECURRENT EXPENDITURE

### **5.1** Personnel Cost/Consolidated Revenue Fund Charges (Salaries)

As for Personnel Cost/Consolidated Revenue Fund Charges (Salaries), MDAs are admonished to prepare detailed *Actual Numbers of Staff* or *Political Office Holders* on their nominal and payroll as well as their expected Total Emoluments for the Year 2025 by using *Template Appendix "C1" and "C"*.

In making the Projections for the year 2025 and final transfer to Appendix C Template, MDAs are, therefore, employed to adopt the following method:

- a. Use the *Appendix* "C 1" Template as an Example and prepare a Detailed List of each Staff, with their individual Basic Salaries and other Allowances while taking into consideration incorporating their yearly increment and promotions for the year 2025 on the respective Personnel where applicable; (Note that the Calculation for an Individual Personnel should be for a year Except for Personnel that may be Retiring from the service before the end of the Year).
- b. Calculate the MDA's Yearly Total which includes the Basic Salary and other Allowances;
- c. Transfer the *MDA's Yearly Total* items i.e. (Basic Salary and Other Allowances) on *Appendix* "*C 1"* to the Template marked as *Appendix* "*C 2"* into the appropriate Column of the Proposed Estimates 2025 by using the appropriate Economic Code from the Chart of Account Provided;
- d. Any Allowance(s) not included in the ones provided in the Chart of Accounts Template, such allowance(s) should be identified and added below with their corresponding projections;
- e. MDAs that their Salaries remain in other MDAs before they were delineated, should liaise with such MDA, compute their actual projection for the year 2025, and deduct it from the actual projection of the other MDA;
- f. The 2024 Approved Budget must be rightly captured and reflected in the column provided; and
- g. Although Resource Envelopes for Personnel Cost has been given to MDAs concerned, the figures generated by the procedures in items **a**, **b** & **c** above will be considered most credible and reliable.

Meanwhile, MDAs may wish to know that changes have been made to the coding and alignment of the Allowances that have been duplicated in the National Chart

of Accounts. In this regard, MDAs are strongly advised to refer to the Chart of Accounts and pick or choose the right code and its applicable narration and reflect it on the row provided.

#### 5.2 Overhead Cost

Under the Government Policy on accountability and transparency in spending public funds, the 2025 Overhead Expenditure is aimed at eliminating duplication and wastage through misallocation of resources. In this regard, MDAs must strictly apply the principle of **Opportunity Cost** to manage scarce resources as contained in the Budget Resource Envelop given to them. To achieve this, MDAs are instructed to:

- a. Justify every allocation made;
- b. Reflect the 2024 Approved Budget in the column provided;
- c. Identify key and active Economic Codes or Subheads and allocate more funds to them; and
- d. Other subheads that have no activities should have Zero allocation to avoid non-performing subheads when it comes to budget implementation.

MDAs are therefore enjoined to identify Economic Codes under **Appendix "D" Template** that are relevant and will facilitate the execution of their activities, allocate a reasonable amount, and above all remain within the given Budget Resource Envelop.

### 5.3 Capital Expenditure

The Government's policy on Capital Expenditure is centered on Priority Areas as mentioned in item **3.1** above. MDAs must first understand that Capital Expenditure Items and Budget Resource Envelopes must be well articulated in line with the priority areas of the Government before they are admitted into the Proposed 2025 Budget.

**Appendix "E" Template** is expected to assist MDAs in identifying projects that will align with the yearnings and aspirations of the Government. To this, MDAs are advised to restrict themselves to Ongoing projects.

They are also directed that admittance of New Projects into the 2025 Proposed Budget must be accompanied by His Excellency's Approval.

MDAs enjoying one or more Loan(s), Aid(s), or Grant(s) from Development Partners, the Federal Government and the Local Government are reminded to capture the activities to be implemented on the Capital Expenditure side by explicitly giving us the narration for such activity involved.

Given the above, all Capital Projects must:

- ❖ Be realistic;
- Be Achievable;
- Be completed within a stipulated period;
- ❖ A priority of the Government; and
- Must obtain His Excellency's approval.

#### **6.0 GENERAL INFORMATION**

It is our firm belief that the identified priority sectors as earlier mentioned will in turn assist the State in improving our socio-economic growth and development. In this regard, we once more wish to highlight and encourage MDAs to adopt the following strategies in achieving the goals of their respective organization which will, in the end, help to translate into socio-economic growth and development of the State:

- a. Identify the goals and objectives of your organization;
- b. Identify programmes and projects that are aimed at achieving the goals and objectives of the organization with government priority;
- c. Spread the programmes and projects over the period of three years most especially where they cannot be completed within a year;
- d. All capital budgets should be derived from priority areas of the Government and must be cost (attach Bill of Quantity).
- e. MDAs must provide a cost-benefit analysis of new capital proposals in their submissions.
- f. Capital proposals, especially new ones, must be supported by an **EXPRESS APPROVAL** of His Excellency for their inclusion into the Budget proposal.
- g. All Capital Expenditure Budget Line Items must carry detailed narration in terms of quantity, specification of product or project, and quality where applicable.

As the year 2025 will mark the second year of the second term of the current Administration's Budget preparation and implementation, MDAS need to ensure

that preparation of the Budget 2025 fiscal year is done in such a manner that the set targets and laudable programmes and projects already recorded by the Government's reform are taken into consideration. It is on this basis that **Resource Envelops** of respective MDAs, **Proposed Estimates 2025 Templates, Timetable** for Budget Bi-lateral Discussion, and **Charts of Accounts** are attached for MDAs **noting and usage**. MDAs are also therefore strongly advised to note the following:

- a. All MDAs are to work out their Budget proposals within the resource envelopes provided as earlier mentioned.
- b. All MDAs should diligently study attached templates for guidance and ease of reference.
- c. All MDAs are to take note of the *date scheduled* against them for discussions.
- d. All submissions in **Soft and Hard Copies** should reach the Ministry of Budget and Economic Planning on or before **15**<sup>th</sup> **August 2024** to allow the opportunity for **Budget Entries** at the Ministry of Budget, Planning and Multilateral Coordination by the respective MDAs before the commencement of the Budget Deliberations/Discussions.
- e. The team for the **Budget Deliberations/Discussions** should be made up of the Honourable Commissioners, Permanent Secretaries, Heads of Agencies, Professional Directors, and Key Budget/Finance and Accounts Staff. However, it is also strongly advised that the Honourable Commissioner should lead the team.
